## **General Product Information**

## **Product Test Conditions**

LUXEON Versat 2020 20 LEDs are tested and binned using a 20 ms monopulse (MP) at 20 mA drive current, case temperature, T., of 25 °C.

### Part Number Nomenclature

Part numbers for LUXEON Versat 2020 20 follow the convention below:

### A 1 V B - A B C D E F G H J K M N P

#### Where:

A – designates product segment (A = Automotive)

1 – designates product level (1 = Level 1)

V – designates product line/family (V = LUXEON Versat)

B – designates package size (B = 2020)

ABCD - designates color variant (O612 = 612 nm minimum)

designates binning current (A = 20 mA)

F - designates binning configuration (1 = single binning)

**G** – open space (0 = Gen3E, A = Gen4, etc.)

H – designates minimum luminous flux (refer to luminous flux bins)

designates maximum luminous flux (refer to luminous flux bins)

K – designates minimum forward voltage (refer to forward voltage bins)

designates maximum forward voltage (refer to forward voltage bins)

**NP** - reserved for custom part numbers (00 = standard part)

Therefore, the following part number is used for a LUXEON Versat 2020 20 Red-Orange with a luminous flux range of 2.1 to 2.6 lm, and a forward voltage range of 1.90–2.50 V:




Figure 1. Typical normalized power vs. wavelength for LUXEON Versat 2020 20 at 20 mA,  $T_c$  = 25 °C




Figure 2. Typical wavelength shift vs. junction temperature for LUXEON Versat 2020 20 at 20 mA




Figure 3. Typical normalized light output vs. junction temperature for LUXEON Versat 2020 20 at 20 mA




Figure 4. Typical normalized light output vs. forward current for LUXEON Versat 2020 20 at  $T_c$  = 25 °C




Figure 5. Typical forward current vs. forward voltage for LUXEON Versat 2020 20 at  $T_c$  = 25 °C




Figure 6. Typical forward voltage shift vs. junction temperature for LUXEON Versat 2020 20 at 20 mA




Figure 7. Typical radiation pattern for LUXEON Versat 2020 20 at 20 mA




Figure 8: Maximum forward current vs. case temperature for LUXEON Versat 2020 20

# **Product Bin and Labeling Definitions**

## Designing with LUXEON Versat 2020 20

Flux bins supportable for car programs depend on product color and program start-of-production and end-of-production dates. Flux roadmaps by year and product color are maintained and available from the sales representative. Please contact a local sales representative to request the flux bin range with best supportability for program timing.

## **Decoding Product Bin Labeling**

In the manufacturing of semiconductor products, there are variations in performance around the average values given in the technical datasheets. For this reason, Lumileds bins the LED components for luminous flux or radiometric power, color point, peak or dominant wavelength and forward voltage.

LUXEON Versat 2020 20 LEDs are labeled using a 3-digit alphanumeric CAT code following the format below:

#### A B C

Where:

A - designates luminous flux bin (example: 7 = 2.1 to 2.6 lm)

**B** – designates color code (example: 3 = 612 to 620 nm)

**C** – designates forward voltage bin (example: D = 2.35 to 2.50 V)

Therefore, a LUXEON Versat 2020 20 with a lumen range of 2.1 to 2.6 lm, color code of 3 and a forward voltage of 2.35 to 2.50 V has the following CAT code:

#### 73D

LUXEON Versat 2020 20 LEDs with split flux bins are labeled using a 4-digit alphanumeric CAT code following the format below:

#### ABCD

Where:

A B - designates luminous flux bin at 20 mA (example: 91 = 3.0 lumens to 3.3 lumens, 90 = 3.0 lumens to 3.6 lumens)

**C** – designates color code (example: 3 = 612 nm to 620 nm)

designates forward voltage bin at 20 mA (example: C = 2.20 V to 2.35 V)

Therefore, a LUXEON Versat 2020 20 with a lumen range of 1.4 lumens to 1.5 lumens, a color code of 3, a forward voltage of 2.20 to 2.35 has the following CAT code:




Figure 9. Mechanical dimensions for LUXEON Versat 2020 20




Figure 10. Pocket tape dimensions for LUXEON Versat 2020 20




Figure 11. Reel dimensions for LUXEON Versat 2020 20




Figure 12.Example of a moisture barrier bag and reel label for LUXEON Versat 2020 20
